#### **The Electronic Supervision Program**

The Electronic Supervision Program (ESP) addresses the judiciary desire for more vigilant monitoring of offenders with community dispositions (conditional sentences) and is an optional condition that can be imposed by a Judge of a Conditional Sentence Order, of an Ontario parole Certificate or of a Temporary Absence Program permit. The ESP is a compliance detection program for offenders deemed suitable for community placement by the releasing authority. Adults 18 and over who are eligible under court order to do part of their sentencing in their home under strict conditions.

#### **Community Service Order**

The Community Service Order (CSO) program is a community based sentencing option. Individuals convicted of an offence are ordered by a Judge to complete community service hours as a way of paying their debt back to society. Generally, CSO is a condition of a probation order or/and a conditional sentence order. The objectives of the CSO program is a) to provide the judiciary with a community based sentencing option that is cost efficient and does not compromise public safety, b) to involve the community in the criminal justice system in a way that benefits both the community and the offender, c) to encourage offenders to demonstrate responsible behavior in their communities and thereby reduce the chance of recidivism.

#### **Intermittent Community Work Program**

The Intermittent Community Work Program (ICWP) embraces the principles of restorative justice within the Ottawa Community and gives male offenders 18 years and older who are serving an intermittent sentence the opportunity to do community hours with a not-for-profit organization in their community instead of spending the week/weekend in jail. Clients qualify based on strict criteria determined by the Ministry of Community Safety and Correctional Services (MCSCS). The ICWP allows the client to continue to live with their family, as well as continue to work enabling the client to have a healthy rehabilitation with family and in the community.

## **Intermittent Community Work Program Substance Use Program**

The Intermittent Community Work Program Substance Use Program (ICWP SUP) allows for clients who serving intermittent sentences for drinking and driving to serve the time in the community instead of being incarcerated. The client will also take part in a seven session information program on alcohol use and its effects from a social, psychological, physiological and legal perspective. The client will receive information about the issues surrounding impaired driving and its impact; about key components and impact of pro-criminal thinking; about various topics necessary for successful reintegration and healthy living including suggested coping skills.

#### Courthouse Office at 1059-161 Elgin Street

The Correctional & Justice Services Ottawa Courthouse Office is a safe space for many people to seek general support and information during a potentially difficult time. General support is provided on a drop-in bases and provides distribution of bus tickets, use of phone, program referrals and other general requests for information and various snack foods when available.

#### **Adult Pre-charge Diversion Program**

The Adult Pre-Charge Diversion is an alternative to the Criminal Justice System for those accused of committing minor offences. The PCD seeks to address minor offences with a holistic approach, providing services and benefits to the offender, the justice system, as well as the community. The (PCD gives those with minor offences an alternative to being charged. Clients are given specific measures to address the behavior that lead to the arrest.

The PCD, in partnership with the Ottawa Police, runs a John School, which is for male clients that have been arrested for solicitation of sex for money. Various presenters including the Ottawa Police, the Crown Office, Public Health, community members and a former Sex Trade Worker provide an informative view of street engaged sex-work.
